Dear Family Member,

Although there are **no reported cases** of COVID-19 Coronavirus at People Inc., we wanted to reach out to update you on precautions we are taking. We know that this is a stressful time, and people want to know what they can do right now to protect themselves and their loved ones.

People Inc. has been proactive in having established an Emergency Preparedness Program six years ago, and training staff, running drills and tabletop exercises since that time. Our staff are routinely trained on Universal Precautions, which have been identified as one of the most effective precautionary measures that can be taken. We have implemented a Telemedicine Program in our group homes and day programs two years ago, which is ideal for quickly assessing health concerns without automatically transporting people we support to what could be crowded community health-care centers.

To stay on top of the current situation, we are actively monitoring the Center for Disease Control (CDC) website, which is the premier source of fact-based and current information. You can also consult the website directly at **cdc.gov**. We are in contact with and monitoring websites of the NYS and County Health Departments and NYS Office for People with Developmental Disabilities, among others.

Our Emergency Preparedness Team is meeting daily to ensure our actions are informed by the most current CDC and Department of Health guidance, and proactive plans are in place and adjusted as needed. We have ordered additional supplies, increased training on cleaning protocols and reasonable precautions, and communicated resources for staff including our on-call nursing line, Employee Service Line and online updates on best practices and tools. We will continue to work with local and state health agencies and key partners in both planning and taking appropriate actions. We are preparing for a range of potential scenarios, which may include holding back on community outings, working with families who may wish to keep their loved ones at home, etc. As a precautionary measure reflecting an abundance of caution, and in observance of guidance from the Department of Health, our updated Visitors Policy is effective at all People Inc. residences\*, day programs, offices and program\* buildings, Family Care homes and Deaf Access Services access to public videophone room.
